

# Leveraging Brownfields

Federal Cross-Cutting





## Cross-Cutting

Federal cross-cutting refers to requirements common to all grants and programs that use federal funding (e.g., the National Environmental Policy Act – NEPA).

When multiple federal grant programs are used to complete a project, advanced coordination with each federal program helps ensure compliance with cross-cutting measures.





### Cross-Cutting

- The EPA forms partnerships with state, tribal, and local entities to protect human health and the environment.
- Most federal grants require an Environmental Review (ER) to be completed as a grant requirement.
- Federal and some state grants may cover the ER, or may not, depending on the original application and grant-specific stipulations.
- If your project is a Brownfields site, Brownfields assessment grants can be utilized to complete the ER for the project, with approval from the EPA Project Manager and in close coordination with other entity(ies) funding the project.

The following are examples of projects leveraging Brownfields funding to support projects with other (HUD or USDA) federal funding.




## Sunrise Ranch Apartments



- City of Henderson \$56,202,968 project.
- 144 units of affordable housing on 7.8 acres of vacant land.
- Up to 60 units for youth transitioning from foster care
- Would also serve Homeless, At Risk of Homelessness, Fleeing/Attempting to Flee Domestic Violence, Dating Violence, Sexual Assault, Stalking, or Human Trafficking and Other Populations.
- HUD funding (\$6,309,000) supported the construction of the affordable and supportive housing project, but EPA Brownfields funded the Phase I ESA and HUD-required ER.

### North Las Vegas Fire Department Training Facility



- CNLV awarded \$1,000,000 in CDBG funding to construct a 3,000 square-foot dedicated training site for the fire department and fire academy.
- The 4.21-acre lot is used as a Public Works' vehicle and equipment storage lot.
- An EPA Brownfields grant was awarded to complete the Phase I ESA and HUD ER for the site.

### Dolores Huerta Resource Center



- One-of-a-kind facility in Nevada.
- Comprehensive resource hub and a place to address the various needs of low-income individuals and families.
- Services of the DHRC would include:
  - o Free or low-cost legal consultations clinic
  - Educational programs
  - General Educational Development (GED) preparation/tutoring
  - Health and wellness services
  - Workforce development
  - Technology access
  - Cultural and arts programs

EPA Brownfields grant was used to complete the Phase I ESA and HUD ER.



### City of Las Vegas Westside Flats Apartments



- City of Las Vegas 0.33-acre vacant urbaninfill parcel.
- \$1,000,000 HOME Investment Partnership (HOME) grant to assist with the construction of 22 units of affordable family housing.
- \$9,500,506 full project cost.
- Located in the Historic Westside Neighborhood in Las Vegas.
- EPA Brownfields grant was used to complete the Phase I ESA and HUD ER.



## Upcoming Project - Amargosa Library

- The Amargosa Library was constructed in 1986.
- A grant awarded through the USDA will provide funding for the renovation and expansion of the library.
- A Phase I ESA and ER are required before receiving USDA grant funding.
- EPA Brownfields funds will cover the Phase I ESA and USDA Environmental Information Document (ER).
