- 2. Nye County
  - a. Analysis of Brownfields Cleanup Alternatives (ABCA) being worked on for the Finance Building for removal of asbestos-containing materials (ACM) in the roof.
  - b. The 2018 RLF is expiring at the end of September. The match requirement has not been met, participation by coalition members in the Quarterly Meeting can be applied towards the match. Coalition members will be contacted to confirm the meetings attended and will be requested to provide an hourly rate, including fringe.
- 3. Nevada Rural Housing Authority
  - a. NRHA Pioche Housing Project (Lincoln County) Abatement and demolition are complete! Half of the 32 units are complete and occupied. The remaining units are expected to be completed by end of the year.
  - b. In southern Nevada, NRH is planning to acquire and rehabilitate a 206-unit project in Laughlin. NRH is working with Mesquite Gaming on this effort.

  - a. Setting up for a Phase II ESA at the former Animal Shelter in Pahrump.
